

June 11, 2019 Minutes

The Coffee County Legislative Body met June 11, 2019 in a regular scheduled meeting at the Coffee County Administrative Plaza at 6:00 PM.

Sheriff Chad Partin proclaimed the meeting open for business.

Pastor Daryl Williams, at Harmony Baptist Church in Tullahoma gave the Invocation and Ashley Kraft led the Pledge to the Flag.

Twenty members were present for the meeting with Commissioner Jackie Duncan serving as chairman in the absence of Mayor Cordell

Chairman Duncan requested a motion to approve the agenda asking that item 10 g. be deleted to be discussed at a later time. Bryan made the motion and Crabtree seconded the motion to approve the agenda. Orrick made a motion to amend the agenda stating that items 10.d. and 10.g. be moved to the end of meeting to be discussed. The amendment was seconded by Ray and passed with 19 yes votes. Miller made a motion to amend the agenda by adding to 10.i. the revised resolution 2019-06 (revised 06-11-2019). Cunningham seconded the motion to amend and the motion to amend passed with 19 yes votes. The motion as amended was approved with 19 yes votes.

Motion made by Orrick and seconded by Kraft to approve the minutes of the previous meeting. The motion was approved with 19 yes votes.

Motion made by Crabtree and seconded by Ray to approve the following notaries as listed: Tonya M. Armstrong, Lawrence Carr, Ashley Cox, Deronda Gail Goodwin, Lindy Tyler Graham, Dara Holt, Caitlin R Jennings, Nadine Knight, Mayme Medina, Debbie M. Moore, Kevin D. Raney, Christina Ross, Blaire E. Smith, and Whitney Vickers. The motion was approved with 19 yes votes.

Under unfinished business discussion was asked for on Resolution 2019-10 and its amendment postponed from the May meeting. The amendment which called for deleting the last sentence from section 10.b. which reads, "For clarification, this definition does not have application to any special event for which the promoter

of that event authorizes attendees to that event to stay overnight on the premises for which such utilization is only for the purpose of the event” failed with a vote of 7 for and 12 against. The main motion, Resolution 2019-10, passed with a vote of 17 for and 1 against.

Under new business, a motion was made by Crabtree and seconded by Ray to approve Resolution 2019-11 which would amend the 1974 Interlocal Agreement among Coffee County, the cities of Manchester and Tullahoma, and the Coffee County Emergency Communications District to provide for the Chairman of the district Board of Directors to serve as an Ex Officio member of the Consolidated Communications Committee. The motion passed with 19 yes votes.

Motion made by Miller and seconded by Ray to approve the following Budget Amendment for Schools: #141-2019-4 General Purpose School Fund. The motion was approved with 19 yes votes.

Motion made by Miller and seconded by Hobbs to approve the following Budget Amendments: Fund 101 General Fund # 101-2019-18, Fund 118 Ambulance Fund # 118-2019-019, Fund 131 Highway/Public Works #131-2019-020, and Fund 152 Rural Debt Service Fund # 152-2019-021, Fund 171 Rural Infrastructure Fund #171-2019-022. The motion was approved with 19 yes votes.

Motion made by Miller and seconded by Hobbs to approve the Coffee County Fund Balance Policy. This motion passed with 19 yes votes.

The 2020 proposed fiscal budget was presented. Coffee County Schools Director Joe K. Pedigo discussed the school budget and entertained questions. Coffee County Sheriff Chad Partin discussed the sheriff department’s budget and entertained questions. The proposed budget is to be voted on at the June 25 commission meeting.

Motion made by Bryan and seconded by Cunningham to approve Resolution 2019-12 to amend Coffee County Zoning Resolution No. 2006-39 to rezone a tract of land at 3014 Hillsboro Highway and the front 150 feet of a tract of land located at 3204 McMinnville Highway from RS-1, Low Density Residential District, to C-2, General Commercial District. The motion was approved with 19 yes votes.

Motion made by Miller and seconded by Tim Stubblefield to approve revised Resolution 2019-06 (revised 06-11-2019). The motion passed with 19 yes votes.

Under other, a motion was made by Debellis and seconded by Joey Hobbs to appoint Dwight Miller as Vice-chairman to Jackie Duncan in the event commissioner Duncan had to be absent and could not perform duties as chairman during the time that Mayor Cordell is absent. The motion passed with 18 yes votes.

Commissioner Kraft presented information on the Exit 105 sewer project which generated discussion and questions.

Commissioner Debellis introduced discussion on a suggestion to have county legislative work sessions instead of caucus meetings.

No committee reports were presented. After statements and announcements and public comments, the meeting was adjourned by Vice-chairman Duncan at 9:15 p.m.
