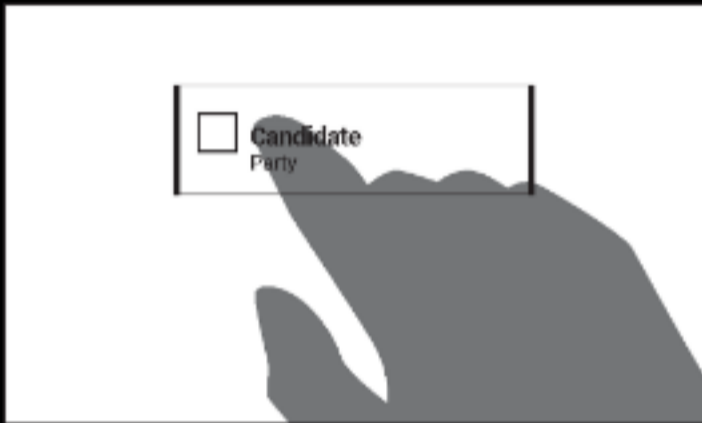




Help
