Requirements for Voter Registration in the State of Tennessee

⇒ You must be a citizen of the United States.

⇒ You must be a resident of the State of Tennessee.

⇒ You must be at least eighteen (18) years old on or before the next election.

⇒ You must have never been convicted of a felony, or have had your rights restored as required by law.

Giving false information to register to vote or attempting to register when not qualified is a felony punishable by not less than two (2) years nor more than twelve (12) years imprisonment or a fine of \$5,000 or both.

VOTING BY MAIL

If you are unable to appear at your polling place on election day or during the early voting period you may request an absentee ballot be mailed to you for one of the following reasons:

1. out of town on election day and ALL days of early voting;
2. full-time student or spouse of student, outside county of residence;
3. hospitalized, sick, disabled or permanent absentee voter with medical statement;
4. caretaker of a hospitalized, sick or disabled person;
5. handicapped voter whose polling place is inaccessible;
6. serving on a state or federal jury;
7. 60 years of age or older;
8. candidate for office;
9. election official, or member or employee of election commission on election day;
10. religious holiday;
11. you or your spouse has a valid commercial driver's license (you must provide a photocopy of license, including the number).

YOUR REQUEST MUST CONTAIN THE FOLLOWING:

1. Name
2. Address as registered in Coffee County
3. Social Security Number
4. Date of birth
5. Address to mail ballot
6. Election type—include party for primaries
7. Voter's signature
8. Reason for request

Note: If you registered by mail you must vote in person for your first election.
