**Notice of Qualifying Deadline**

NOTICE: Pursuant to T.C.A. Section 2-12-111 (a) notice is hereby given that on Thursday, August 1, 2024 the State Republican and Democratic Primaries, County General, Manchester and Tullahoma City elections will be opened and held in all voting precincts within Coffee County.

Offices qualifying for August:

**State Republican and Democratic Primary:**

United States Senate, United States House of Representatives (4<sup>th</sup> Congressional District), Tennessee State Senate (16<sup>th</sup> Senatorial District), Tennessee House of Representatives (47<sup>th</sup> House District), State Executive Committeewoman (2 Year Unexpired Term).

**Coffee County General Elections:** Property Assessor, County Commissioner Districts 1 & 2 (2 Year Unexpired Terms), Road Commissioner Seat 2-District 4 (2 Year Unexpired Term), County School Board Members, Constable Seat 3-Districts 5-8-9 (2 Year Unexpired Term).

**Municipal Elections:**

Manchester City – Mayor, 3 Aldermen – 4-year terms, School Board - 2 Seats for 4 Year Terms

Tullahoma City –Mayor, 3 Aldermen- 4-year terms, School Board - 3 Seats for 4 Year Terms, 1 Seat (2 Year Unexpired Term).

The deadline to file **NOMINATING PETITIONS and CERTIFIED DUPLICATE NOMINATION PETITIONS (when required) for the State Republican and Democratic Primaries, Manchester and Tullahoma City Elections is on Thursday, April 4, 2024 at 12 noon.** Petitions for local candidates may be filed with the Coffee County Election Commission. T.C.A. Section 2-5-102 (b, 1) requires that all nominating petitions be obtained from the Election Commission Office and NO photocopies will be accepted. **INDEPENDENT CANDIDATES FOR THESE OFFICES MUST ALSO FILE BY THURSDAY, APRIL 4, 2024 at 12 noon.** Information on filing may be obtained by contacting the Election Commission Office, 1329 McArthur Street, Suite 6, Manchester, TN. Office hours are 8:00-4:30 Monday-Friday. Phone 723-5103. Fax 723-8279 or Visit our website at [coffeecountyttn.gov/158/election-commission](http://coffeecountyttn.gov/158/election-commission). The withdrawal deadline will be Thursday, April 11, 2024 at 12:00 noon. Any candidate wishing to withdraw must do so in writing and must include the candidate's signature. The absentee by mail request deadline is Thursday, July 25, 2024. Election day hours for all Coffee County voting precincts will be 8:00 a.m. until 7:00 p.m.

**Any eligible person who has not yet registered to vote may do so on or before the Tuesday, July 2, 2024 deadline.** The last day for a name changes, address change or to make any other alterations to the registration records is Saturday, July 27, 2024. If a voter has not updated their registration to their current address, you may have to vote by completing a fail-safe affidavit and may experience a delay in voting or being transferred to another voting location on election day. Registration forms are available at the Election Commission office, Department of Motor Vehicles, Department of Human Services, the Tullahoma Health Departments or by using a registration by-mail form available at the Tullahoma Post Office or Public Library Branch or go online to [www.govotetn.com](http://www.govotetn.com). **Registrations by-mail must be postmarked by Tuesday, July 2, 2024. NOTE: If you register by-mail state law requires that you vote the FIRST TIME in person during early voting or on election day. THE ELECTION COMMISSION OFFICE WILL BE CLOSED Thursday, JULY 4, 2024 FOR INDEPENDENCE DAY.**
